
### TENDER CORRIGENDUM NOTICE.

This office had issued e- tender No. 1652- for Micro Unmanned Aerial Vehicle (UAV) / Drone on 29/01/2018.

2. However, M/s MEDBIT Technologies Noida, M/s Tech Movers Systems (India) Ltd., Mumbai, M/s Ascom Systems, Ms/ Idea Forge Technology Pvt. Ltd. Navi Mumbai & IIO Technologies Pvt. Ltd., Bangalore raised queries regarding above mentioned tendered item. Hence, after detailed scrutiny of the queries this office has decided to issue a corrigendum for the above mentioned e-tender as mentioned below:-

Sr. No.	Corrigendum
1	<b>Tender Para No. (10):-</b> (ii)- Earnest Money Deposit (EMD): the Earnest Money Deposit Rs.1,00,000/- should be paid online using payment gateway. If the tenderer is exempted from submitting the EMD, it should be mentioned on the original letter head along with the copies of G.R. / Govt. order. The exemption must be for the tendered item (i.e. The firm must have the certificate mentioning registered with C.S.P.O. / D.G.S.& D. /NSIC / SSI/ <b>MSME</b> unit for the tendered item. (iii) Registration Certificate of C.S.P.O. / D.G.S.&D. / NSIC / SSI / <b>MSME</b> with validity of registration should be mentioned clearly. If the validity is expired fresh validity should be uploaded. Please note that tenderer whose validity certificate is expired are not eligible for exemption. Such bids are liable for rejection. Also applications made to the concerned authority for issuing fresh validity certificate are not acceptable. Only fresh validity certificate is acceptable for exemption.
2	<b>Specification Point No. 2.6 :-</b> Minimum 40 minutes with operating altitude of 200 m AGL or more.
3	<b>Specification Point No. 4.1 :-</b> Ground Control Station can be a portable Laptop / tablet instead of a tough book with 10 inches or more screen size.
4	<b>Specification Point No. 6.1 :-</b> 90 cm X 90 cm ( + 10 %).

**Other request regarding change in tender specification made by above mentioned vendors is rejected.** As per purchase policy of Government of Maharashtra this office decided to extend the tender period by 5 working days. Hence all bidders are requested to take a note of the same.
